- Payroll processes and HR reporting: Ensure accurate and timely processing of employee compensation and benefits. This includes overseeing payroll administration in Belgium and France, coordinating with finance and accounting departments, and ensuring compliance with relevant laws and regulations. Follow up on HR KPIs and provide data to management (dashboard).
